Call to Order

Chairman Keenan called the meeting to order at 12:05 p.m.

Citizen Comment:

Administration:

- Financial Reports: Mr. Berry presented the financial summary for the month of January.
- <u>Introduction of Christine Thomas as new Executive Director:</u> Mr. Berry introduced Christine Thomas as the new Executive Director. Mrs. Thomas is currently the Executive Director of the Quitman Chamber of Commerce and will begin with the WCEDC on March 1st.

• <u>Strategic Plan Update</u>: Chairman Keenan presented an update on the strategic plan. Chairman Keenan presented the components of the strategic plan as well as an update on the process. Chairman Keenan said he will present the strategic plan to the Commissioners Court on March 7th.

Featured Committee Reports - Additional Reports as Needed

Marketing: Mr. Eggleston presented the Board with an update from the Marketing Committee. Mr. Eggleston announced that distribution has begun on the new travel brochure advertising Wood County. Mr. Eggleston also stated that he and Mrs. Thomas had an interview with KETK in Tyler on February 17th discussing the travel brochures.

- Economic Development Committee: Mr. Lindholm presented the Board with an update from the Economic Development Committee. Mr. Lindholm said that himself and Quitman Mayor Randy Dunn met with State Representative Cole Hefner and State Senator Bryan Hughes to discuss appropriations funding through the current legislative session for the Memory Care project in Quitman. The Memory Care board of directors is seeking \$50-\$60 million in funds to complete the project from the State. Mr. Lindholm also said they will be meeting with U.S. Congressman Lance Gooden to discuss appropriations from the U.S. Congress.
- Government Affairs: Dr. Langley and Mrs. Wallace presented an overview and progress of the Jarvis Workforce Board. The Workforce board is comprised of several employees of the largest industries in Wood County, school officials, retired workforce professionals, WCEDC board members, and leading professionals representing Jarvis Christian University. Their goal is to identify and create solutions to workforce issues in Wood County including lack of labor and soft skills. The board identified several of these issues and are working with county leaders and state workforce to help bring attention to these needs and bring in funding. Currently, JCU is proposing a large project that will allow their campus to host a workforce office and training center in Wood County. Mrs. Wallace and Dr. Langley presented this project to the WCEDC board as they seek funding for it.
